## 2020 Block Party

- There was a recommendation to host a virtual community pizza night for each HOA resident. By
  unanimous vote, the HOA board will provide a pizza to every resident in replacement of the block
  party. To serve as confirmation, all residents must be registered on the HOA community website
  and instructions will be listed during the appointed time for homeowners to receive their pizza.

# 2020 Landscaping

- Residents should not be placing yard waste into the common areas

#### **Pond Maintenance**

- Environment Aquatic Management provides our full-service maintenance for our ponds and fountains.
- HOA Board has new fountain equipment installed, including a new 3rd fountain in our east pond
- Residents should notify people that are fishing in the community ponds that they are trespassing because damage could be caused to our new fountains
- We will have an electrician identify what is causing fountains to shut off

• It was also identified that residents were placing waste into the pond. We ask that no resident places any waste in the ponds as it impacts our cost of maintenance and it is against the law

# **Community Rules & Regulations**

- Adherence to the current HOA by-laws should be enforced.
- Residents should ensure they are requesting board approval for noticeable modifications to homes (Fixtures, landscaping, paint colors, etc.)
- Visible home maintenance (paint, landscape, trash, etc.) and upkeep should be honored by every homeowner as our by laws require it and property values are impacted by residents that fail to comply

# **Open Community Forum**
